A progressive disease that attacks the brain. It is the most common form of dementia.



**Economic crisis** 

- 1 in 10 people age 65 +
- 1 in 3 age 85 +
- 92,000 Minnesotans age 65+
- 250,000 Minnesotans are caregivers
- most expensive medical condition in the U.S. 1 in 5 Medicare \$
- If the number of patients triples as projected in the years ahead, the cost to care for them will exceed **\$1.1** trillion.
- Future costs will bankrupt Medicare, Medicaid, and the life savings of millions of Americans.

# What has been accomplished?

- Libraries engaged book club bags , other literature



## AAAA Role in REACH

- Partnered with MN Board on Aging in a federal Alz. Demonstration grant
- Funded 3 REACH Pilot Sites to serve 40 dementia caregivers
- Engaged 3 local organizations employing caregiver consultants to be trained for pilot
  - Northwoods Partners in Ely
  - · Age Well Arrowhead in Duluth
  - Volunteer Services of Carlton County
- Conducted outreach to medical community and others to help build referral system
- Monitored pilots
- · Encouraged others to be trained



# What is REACH designed to accomplish?

- · Teaches caregivers how to -
- reduce stress
- · solve problems and
- · manage difficult behaviors.
- Builds caregiver confidence and
- Improves caregiver's ability to cope.



## How is REACH Delivered?

#### Assessment

- 28 questions about caregiving
- checklist of behaviors they are seeing in person with dementia


#### Sessions

- 4 core counseling / education sessions personalized to caregivers needs
- Additional sessions if requested / needed

Over 2-3 month period

# Behaviors – examples

- · Sleeping all day, up at night
- Showing little interest in daily activities
- Refusing to bathe
- Verbally aggressive to others
- Expressing feelings of sadness appears depressed
- · Refusing to eat
- Following you everywhere
- Seeing people or things that are not there
- Having problems with dressing
