Adopt amendment to the FBL Fee Schedule

At the February 9, 2016, Aitkin County Board meeting, I proposed adding a fish house site fee to the Food, Beverage and Lodging (FBL) Fee Schedule. After lengthy discussion, the Board requested that I meet with the resort owners to resolve concerns they had with the proposed amendments and return to the Board at a later date with an agreeable solution. Concerns raised by the resort owners will require amending the Mobile Home Park (MHP) and Recreational Camping Area (RCA) Ordinance. A public hearing has been set for June 14, 2016, at 3:00pm, for the proposed amendment to the MHP and RCA Ordinance.

Enclosed is the proposed FBL fee schedule which includes a site fee for the fish house campsites. This fee was discussed with the resort owners who agreed the fee was reasonable. I will be requesting approval of the amendment to the FBL fee schedule with an effective date of January 1, 2017.
