RESOLUTION AUTHORIZING SIGNING AUTHORITY ALLOWING ACCESS TO MINNESOTA GOVERNMENT ACCESS (MGA) ACCOUNTS FOR ELECTRONIC COURT RECORDS AND DOCUMENTS

WHEREAS, the new Minnesota Government Access Accounts, allowing government agencies to view appropriate electronic court records and documents stored in the Minnesota Court Information System for cases in Minnesota district courts, require authorization from the governing body.

NOW, THEREFORE, BE IT RESOLVED, the County Board of Aitkin County, Minnesota as follows:

- 1. Approves and authorizes Scott A. Turner, Aitkin County Sheriff, to sign the Master Subscriber Agreement for Minnesota Court Data Services for Governmental Agencies.
- 2. That the Aitkin County Sheriff, Scott A. Turner, is the designated Authorized Representative for the Aitkin County Sheriff's Office. The Authorized Representative is also authorized to sign any subsequent amendment or agreement that may be required by the State of Minnesota to maintain the County's connection to the systems and tools offered by the State.
- 3. To assist the Authorized Representative with the administration of the agreement, Undersheriff John Drahota, is appointed as the Authorized Representative's designee.
- 4. That Commissioner Mark Wedel, the Chair of the County Board, and Patrick Wussow, the Interim Board Clerk, are authorized to sign this Resolution.
