Summary of Issue: Aitkin County has received a State of MN Bonding grant of \$1,500,000.00 for the purpose of connecting the East side of Mille Lacs Lake to the existing Northwood's ATV Trail System. In order to access the bonding grant, Aitkin County must first pass a resolution stating that a local match of \$150,000 of non-state funds must first be secured. Please see the attached memo for further details on securing the local match and on the Northwood's ATV Trails. The subsequent step in the process will be to then hire an Engineering firm for trail layout, design and construction. Assuming a resolution stating that the local match is secured, I am requesting permission to issue a Request for Proposals to firms that would perform the those services. The RFP would be advertised as well as sent to firms that have been known to do trail work.		
Alternatives, Options, Effects on Others/Comments: Total cost of the local match is \$150,000; \$70,000 CIP, \$65,000 Ec Dev Reserve, \$15,000.00 Mille Lacs Trails. No levy		
or general fund money will be used.

RESOLUTION TO MOVE FORWARD WITH NORTHWOODS ATV TRAIL SYSTEM

WHEREAS, Aitkin County has been awarded State Bonding Funds in the amount of \$1,500,000, from the 2018 bonding bill by the State of Minnesota for predesign, design, acquisition, and development of a trail to connect the Northwood's ATV trail system with the Mille Lacs-Malmo East community trail. The appropriation is not available until the commissioner of management and budget determines that \$150,000 has been committed to the project from non-state sources.

BE IT RESOLVED that Aitkin County has the legal authority to receive financial assistance, and financial capability to meet the match requirement and ensure adequate construction, operation, maintenance and replacement of the proposed project for its design life.

BE IT FURTHER RESOLVED that Aitkin County has secured the required \$150,000.00 in non-state funds for the local match. Aitkin County funds for the local match will be made available for project costs and expenses as incurred under the scope of this project.

BE IT FURTHER RESOLVED that Aitkin County has not incurred any acquisition or development costs.

NOW, THEREFORE BE IT RESOLVED that <u>THE AITKIN COUNTY ADMINISTRATOR</u> is hereby authorized to execute such agreements as are necessary to implement the project on behalf of the Aitkin County.

SUBJECT: Local Match and RFP for Mille Lacs East ATV Trail

Aitkin County has received a State of MN Bonding grant of \$1,500,000.00 for the purpose of connecting the East side of Mille Lacs Lake to the existing Northwood's ATV Trail System. Previously the Board passed a resolution agreeing to be the grant sponsor and administrator. The next step, in order to access the bonding grant, Aitkin County must first pass a resolution stating that a local match of \$150,000 of non-state funds are secured. This is obviously a great opportunity for Aitkin County to make a significant investment of \$1,500,000.00 in an important piece of one of our economic engines, trails, for the cost of \$150,000.00. Some figures on the Northwood's ATV Trail System;

- * Since the implementation of the Northwood's, Aitkin County Campground receipts have nearly tripled, 3 of the 4 campgrounds have direct access to the trail.
- * Starting with the 2019 riding season the Land Department placed trail counters in selected areas, 11,974 riders were counted through August on the various trails and connectors, other than the Red Top Trail that the club has trail counters. The club's counters show an average of 425 riders per week on the Red Top. So, approximately, 18,349 riders have used our trails with 2 months remaining in the season.
- * For the 2016 and 2017 we had a counter on the Northwood's ATV Trail website; in 2016 we had 8,599 unique visits to the site and in 2017 that number climbed to 28,645.
- * A Dovetail Partners report was commissioned shortly after the trail opened on the impact of the Northwood's ATV on area businesses. All of the businesses that took part in the survey had experienced some increase in business with 42% seeing a modest increase and 25% seeing a significant increase. These numbers will all have increased now the trail has been in use for an additional 5 years since the survey.

There is no doubt that the Northwood's ATV Trail System is having a positive effect on the Aitkin County Economy. Again, we have the opportunity to not only expand ridership opportunities but connecting the trail to the food and lodging amenities in the East Mille Lacs area is a win-win for riders and the community. My recommendation for funding the local match is as follows;

 \$65,000.00 from the Economic Development reserve fund. After our obligations to the Aitkin County Broadband Grants there will be approximately \$75,000.00 remaining in this fund. The purpose of the reserve fund is economic development projects. I feel similar to Broadband, this is an investment in Aitkin County infrastructure that will pay dividends for years to come. I can't think of a better way to use those remaining funds.

- \$70,000.00 from the Land Department 2021 Capital Improvement budget. The Land Department is planning to purchase equipment for ATV trail building and maintenance that we would purchase from grant funds for ATV trail use.
- \$15,000.00 from the Mille Lacs Trails Snowmobile and ATV Club. In addition to contributing 10% of the match, Mille Lacs Trails has also agreed to be the trail sponsor.


