Project Identification: Airport Maintenance and Operations Activities.

This amendment is by and between the State of Minnesota, through its Commissioner of Transportation ("State") and City of Aitkin acting through its Airport Commission ("Recipient").

**Recitals**

1. The State has a contract with the Recipient identified as MnDOT Contract No. 1033572 ("Original Contract") to provide reimbursement for eligible airport maintenance and operations activities.
2. The Original Contract is being amended to include additional Federal CARES Act funding.
3. The State and the Recipient are willing to amend the Original Contract as stated below.

**Contract Amendment**

In this Amendment deleted contract terms will be ~~struck-out~~ and the added contract terms will be underlined.

**REVISION 1.** Article 5.1. **Consideration** is deleted in its entirety and replaced with the following:

- 5.1. **Consideration.** State will pay for all eligible telecommunication, maintenance, and operation costs incurred by Recipient under this Contract as follows:
  - 5.1.1. **State Funds Reimbursement Basis.** Recipient will be reimbursed for 100% of telecommunication costs associated with the operation of state-owned navigational aids. Recipient will be paid for 75% of all other state-eligible maintenance and operation costs not reimbursed by any other source. Eligible maintenance and operations costs will be determined at the sole discretion of State's Authorized Representative.
  - 5.1.2. **Federal Funds Reimbursement Basis.** Recipient will be reimbursed for 100% of federally-eligible operating expenses not reimbursed by any other source. Eligible operating expenses will be determined at the discretion of State's Authorized Representative, in cooperation with the Federal Aviation Administration's local Airport District Office. Eligible expenses will be determined in accordance with the Federal Aviation Administration's Policy and Procedures Concerning the Use of Airport Revenues, 64 Federal Register 7696 (64 FR 7696), as amended by 78 Federal Register 55330 (78 FR 55330), which is incorporated into this agreement by reference, and the CARES Act.
  - 5.1.3. **Priority of Reimbursement.** Costs that are eligible for both federal and state reimbursement will be reimbursed with federal funds, if available. If the federal funds available under section 5.1.6 of this agreement have been exhausted, these costs will then be reimbursed with state funds, if available.
  - 5.1.4. **Telecommunication Amount.** State has currently obligated \$0.00 in each State fiscal year to reimburse eligible telecommunication costs at 100%.
  - 5.1.5. **State Maintenance and Operation Amount.** State has currently obligated \$30,030 of state funding in each State fiscal year to reimburse other eligible costs at 75%.

There certainly is not enough business year round to support two off sale liquor stores within such close proximity. Westerlund's can expand other areas of their gas station to accommodate needs that Malmo is lacking, such as an expanded grocery selection.

**AN ORDINANCE TO ENACT A TEMPORARY MORATORIUM ON THE ISSUANCE OF NEW BUSINESS LICENSES TO LIQUOR STORES SEEKING TO OPERATE IN AITKIN COUNTY**

Whereas, Aitkin County Commissioners have a responsibility to protect long established Ma and Pa businesses in Aitkin County.

Whereas, the residents of Aitkin County have expressed concerns with the number of liquor stores in Malmo Township and have objected to the addition of any new liquor stores in Malmo Township as demonstrated by over 900 people signing Gene Miller's petition, owner of Tj's Liquor in Malmo Township.


Whereas, with the increasing number of liquor stores operating in South Aitkin County, we deem it necessary and appropriate to place a temporary 120 day moratorium on the issuance of new business license to package stores that sell alcoholic beverages, such as spirit, wine, and beer, in Aitkin County to allow Aitkin County Commissioners time to determine whether South Aitkin County is over-saturated with Alcohol retailers and to research the relationship between accessibility and/or location of liquor stores. The 120 day moratorium would provide time for the Aitkin County Commissioners to study the impact of an additional retailer upon the following well established off sale liquor retailers: Castaways Resort, Barnacles Resort, Pine Inn, Poor Lewy's, The Joint, Lakeview Inn, The Cave Liquors, Glen Store, and Tj's Liquor,


Whereas, this 120 day moratorium established on the issuance of any new business license to package stores which sell alcoholic beverages, such as spirits, wine, beer, within the geographical boundaries of Aitkin County will take effect May 26, 2020. This moratorium shall only apply to new business that do not have a current business liquor license.



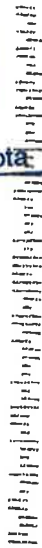


