Summary of Issue: Aitkin County Land Department budgeted \$50,000 for two (2) 4x4 extended cab pickup trucks with towing capacity. Sealed bids quotes were solicited to area vendors. Three (3) quotes were received. Tanner Motors (Brainerd) Dodge - 2018 Ram \$ 49,390 Aitkin Motors (Aitkin) Ford - 2019 F150 (Ecoboost) \$ 51,970 Dondelinger (Baxter) Chevrolet - 2019 Silverado 1500 LD (Double Cab) \$ 53,674 ACLD would request that it be allowed to purchase 2 trucks Aitkin Motors due to: 1) the cost savings of time and travel for warranty service, 2) both trucks would be 2019 models, and 3) providing business to a local area vendor Cost difference of \$1,970 would be paid for from funds generated by 2018 vehicle and equipment sales. New trucks would be received within 60 days.		
Alternatives, Options, Effects on Others/Comments: Alternative: Purchase 2018 Dodge trucks from Tanner Motors Brainerd for an initial savings of \$2,580. However, warranty service and associated time and travel of staff to and from Dodge dealership would exceed initial cost savings.		
Recommended Action/Motion: To approve purchase of 2 pickup trucks from local area merchant Aitkin Motors - Ford.
