We have received bids for our budgeted 2020 squad purchases. The bids are for 2021 models, and include the 3.3L V6 AWD Ford Police Utility Vehicle (PUV), the Ford 3.0L Eco-Boost PUV and the Chevrolet Tahoe 4x4.
