Strateligent LLC. – CREATIVE SERVICES AGREEMENT (The "Agreement") Aitkin County – 307 2nd St NW, Room 310 Aitkin, MN 56431

AGREEMENT dated Thursday, June16th, 2022 by and between Strateligent, LLC, a Minnesota Limited Liability Company (hereinafter referred to as "Strateligent") and Aitkin County (hereinafter referred to as the "Client").

- 1. Services. The Client hereby retains Strateligent, and Strateligent hereby agrees, to perform media services in accordance with the terms and conditions set forth herein. The specific services that are being provided by Strateligent for the Client are noted within this contact under point (4) Creative Service Deliverables and Fees.
- 2. Term. The term of this Agreement shall commence on June 16th, 2022 and continue through June 15th, 2023 (12 months) or the date on which Client utilizes the 280 hours of service budgeted in this Agreement, whichever comes later.
- 3. Creative Services. Client agrees to pay services rendered from the payment schedule as detailed below as a retainer for anticipated fees and expenses.

This agreement includes a budget of up to Two Hundred Eighty (280) hours total.

4. Creative Service Deliverables and Fees.

All production expenses such as printing, mailing, advertising insertion, are not included within this retainer and will be billed additionally as produced. Strateligent will gain client approval on all production expenses in addition to this creative services agreement.

- 5. Expenses. Client is responsible for payment of all expenses incurred in advertising, distribution, and all out-of-pocket costs. Client agrees to pay all expenses relating to Media Services provided. Strateligent will gain client approval on all production expenses in addition to this creative services agreement. This may include publication costs, advertising expenses, development expenses, and all expenses associated with the Media Services to be provided. Client understands and agrees that Strateligent is not responsible for costs and expenses during the development, creation, use or production of the Media Services. Client agrees to pay all such anticipated costs and fees in advance to Strateligent. Under most circumstances, Strateligent will set up production billing to go directly to the client. Client will only pay for those additional expenses for which Strateligent has obtained prior approval from the Client.
- 6. Deliverables. Two Hundred Eighty (280) hours of Strateligent's creative services are budgeted for Client's projects. These creative services include, but are not limited to, strategic consulting, creative conception, project management, art direction, graphic design, media direction (advertising contracts and the distribution of ad media), web development within WordPress, copywriting, search engine copywriting, social media consultation, and public relations content creation and story pitching related to the communication and identity plan for the client.



7. The Client's Acknowledgment, Confirmation and/or Approval. If required, the Media Services provided may be confirmed, acknowledged and/or approved by the Client through email, mail and other forms of communications. Unless otherwise specified, approval is presumed if production is initiated. Also, the Client specifies the following persons as authorized to acknowledge, confirm or approve the Media Services agreed upon herein:

- **8.** Independent Contractor Status. Strateligent and the Client agree that Strateligent is an independent contractor and shall not be treated for any purpose as an employee.
- 9. Non-Solicitation and No-Hire. Client understands that Strateligent has time, energy, and money invested in the training and advancement of Strateligent's employees. Client also understands that Strateligent's employees are subject to non-compete agreements. Client agrees to not solicit or retain any Strateligent employee/consultant on a full-time, part-time, project-wise, or in any other capacity as an independent contractor, employee, or consultant, within one (1) year after signing this Agreement. Notwithstanding the foregoing, Client may retain a Strateligent employee with the express written consent of Strateligent.
- 10. No Guarantee as to Results. Strateligent believes that it provides the highest quality media services. Strateligent will work hard to maintain its reputation to provide the Client with quality media services. However, Strateligent does not represent or guarantee the volume, quantity, results or response from the media services provided. Strateligent makes no warranties, all warranties, express and implied, are expressly disclaimed.
- 11. Excuse from Performance. Strateligent will do its best to provide quality Media Services in a timely fashion. However, if there is sickness, disability, Court order, problem with delivery of media services (subcontractors) lack of payment, or other event that would reasonably delay the completion of the Media Services, Client agrees that Strateligent will not be held responsible for delays.
- 12. Terminating the Agreement. The Client may by written notice, terminate this Agreement in the event of untimely work or missed submission deadlines by Strateligent, Strateligent shall have a right to cure such breach within 15 days of receipt of written notice. At the time of this contract being terminated the total hours rendered by Strateligent versus the hours paid by the client will either be invoiced in full (if hours rendered exceeds hours paid), or refunded to the client (if hours rendered are under the hours that have been paid).
- 13. Licensed Photography and Artwork: Strateligent is licensed to use photography and artwork through Getty Images. The license agreement with Getty Images precludes the use of the photography/artwork by non-licensed persons. The Client understands that the photography and artwork cannot be used without the authorization or permission of Strateligent, as permitted by its license. The Client understands that the Media Services may include photography/artwork of Getty Images. If photography/artwork is used in the Media Services, client agrees and understands that the redistribution (after completion of the Media Services) without the consent/permission of Strateligent in accordance with the license granted to Strateligent is not permitted. At no time will Strateligent have the ability to transfer the actual digital file of a Getty Images photo or illustration to the client as this would be against the license rights of the image. At any time, the client may purchase the licensing rights to a Getty Images photo or illustration and an additional cost if they would like to use the photo on their own behalf outside of Strateligent.
- 14. Indemnify and Hold Harmless. Each party shall be liable for its own acts to the extent provided by law and hereby agrees to indemnify, to hold harmless, and to defend the other, its officers and employees against any and all liability, loss, costs, damages, expenses, claims, or actions, including attorney's fees which the other, its officers and employees may hereafter sustain, incur or be required to pay, arising out of or by reason of any act or omission of the party, its agents, servants, or employees, in the execution, performance, or failure to adequately perform its obligations pursuant to this Contract.
- **15. Collection:** The Client promises to pay all costs of collection, including but not limited to reasonable attorneys' fees, paid or incurred by Strateligent on account of such collection, whether or not suit is filed with respect thereto and whether such costs or expense is paid or incurred, or to be paid or incurred, prior to or after the entry of judgment.



16. Miscellaneous.

- a. Complete Agreement. This Agreement contains the entire agreement among the parties, superseding in all respects any and all prior oral or written agreements or understandings pertaining to the subject matter hereof and transactions contemplated hereby.
- b. Waiver. No waiver by either party of any condition, or of the breach of any term or covenant contained in this Agreement, whether by conduct or otherwise, in any one or more instances shall be deemed to be or construed as a further and continuing waiver of any such condition or breach or a waiver of any other condition or breach of any other term or covenant of this Agreement.
- c. Third-Party Beneficiaries. There are no third-party beneficiaries under this Agreement.
- d. Assignment. Neither party may assign any of its rights or obligations hereunder, whether by operation of law or otherwise, without the other party's prior written consent (not to be unreasonably withheld). Subject to the foregoing, this Agreement will bind and inure to the benefit of the parties, their respective successors and permitted assigns.
- e. Governing Law. This Agreement shall be governed, enforced and construed under the laws of the State of Minnesota.
- f. Severability. If any provision of this Agreement is held by a court to be contrary to law, the provision will be deemed null and void, and the remaining provisions of this Agreement will remain in effect.
