Summary of Issue: Authorization by the following resolution is requested to make final payment to Knife River, Sauk Rapids, MN in the amount of \$13,939.55 for Contract No. 20217, which included the following projects: CP 001-079-002 - bituminous resurfacing on 0.5 mile of CH 79 in the city of McGrath SAP 001-030-006 - bituminous patching and aggregate surfacing on CH 22, 23, 24 and 60 SAP 001-609-004 - bituminous resurfacing on 0.8 mile of CH 9 in the city of McGrath SAP 001-625-002 - bituminous surfacing on 3.3 miles of CH 25 in Wagner Township The final contract amount of \$1,393,956.05 is 2.9% above the bid amount of \$1,354,467.68. The increased final cost was due to slightly increased quantities of bituminous pavement needed to construct the road as designed and contract incentive payments for achieved pavement density and ride quality.
