The Aitkin County Board of Commissioners met this 25th day of April 2023, at 9:00 a.m. as the Aitkin County Health & Human Services Board with the following members present: Board Chair, Commissioner J. Mark Wedel, Commissioners Laurie Westerlund, Travis Leiviska, Bret Sample and Michael Kearney. County Administrator Jessica Seibert, Health & Human Services Director Sarah Pratt, and Administrative Assistant Paula Arimborgo. Others present included: H&HS Supervisors Carli Goble & Erin Melz, ACHHS Advisory Committee members Patrick Blunt and Jon Moen, Jeanne Schram Aitkin Age, and other public guests. Joining via WebEx: Mark Jeffers, AC Economic Development.

Approved Agenda

Motion by Commissioner Kearny, seconded by Commissioner Leiviska and carried, all members present voting yes to approve the April 25, 2023 Health & Human Services agenda.

Approved Minutes

Motion by Commissioner Westerlund, seconded by Commissioner Sample and carried, all members present voting yes to approve March 28, 2023 Health & Human Services minutes.

Motion by Commissioner Leiviska, seconded by Commissioner Westerlund and carried, all members present voting yes to approve the bills.

Director Updates

Sarah Pratt, H&HS Director updated the board on the following:

- Re-instatement of Healthcare renewals
 - o New federal requirement to offer phone renewals
 - Aitkin County will receive \$115,000 in funding sometime during the first couple weeks of July.
 - There is no deadline to spend the funds.
 - Must keep track of expenditures and maintain supporting documentation.
 - Funds can be spent on OT pay, hiring and training staff, technology, etc.
 - Currently we are evaluating our long and short-term needs based on the changes.

- Long Term Services & Support (LTSS) Business Process Review
 - In 2022, Public Consulting Group conducted LTSS business process reviews of at least 15 lead agencies on behalf of DHS.
 - Aitkin County volunteered to participate in efforts to provide DHS a rural, small community perspective.
 - It was a collaborative effort between our Financial Services department and our Home & Community Based Adult Services team to review our processes on how someone accesses long term services and supports in our county.
 - Notable strengths: team approach, longevity of staff, flow of communication between units, and internal standard operating procedures.
 - Areas to consider for improvement: assuring technology is appropriately meeting needs and review current software, systems, and storage means to ensure they are effective and efficient.
- MnCHOICES revision
 - DHS is planning to adjust the MnCHOICES partner-advised rolling launch and add a beta phase.
 - There will be four phases:
 - o Beta Phase: May 1 June 20, 2023
 - Phase 1: Guidance & Training through September 2023, 10% of users in production of new system
 - Phase 2: Ongoing Training, 30% of users in production of new system
 - Phase 3: Ongoing training, 100% of users in production of new system.
 - Phase 4: final transition period, the old system will be deactivated May 31, 2024.
- HHS will be celebrating Employee Appreciation Day tomorrow. We will be having a baseball themed celebration and lunch will be provided to the staff along with some giveaways.
- Legislative Updates: Attending MACSSA meeting this week. With May being the end of the first legislative session, I will be able to provide updates on where things are at during the May Board meeting.
