One of those trucks was purchased in April. The other one is now available for pickup. The purchase was made through the State Bid Contract, which is processed and delivered by Aitkin Motors (local vendor). Attached is the quote for the truck - 2023 F150 4x4. The expenses are listed below. Cost \$38,662.00 Motor Vehicle Tax \$2.513.03 Title and Transfer \$165.00 Total\$41,340.03 **Alternatives, Options, Effects on Others/Comments:** ACLD is tax exempt however, a 6.5% Motor Vehicle Tax is required.
