ESTABLISHING AN ABSENTEE/MAIL BALLOT BOARD

WHEREAS, by ordinance or resolution, the governing body of Aitkin County is required by Minnesota Statute 203B.121 to establish a ballot board to accept and reject absentee and mail ballots; and

WHEREAS, this Board will bring uniformity in the processing of accepting or rejecting returned absentee and mail ballots in Aitkin County; and

WHEREAS, the Absentee/Mail Ballot Board would consist of a sufficient number of Election Judges as provided in Sections 204B.19 to 204B.22;

THEREFORE BE IT RESOLVED THAT, the Aitkin County Board of Commissioners hereby establishes an Absentee/Mail Ballot Board that would consist of a sufficient number of Election Judges as provided in Minnesota Statute 204B.19 to 204B.22 to perform the task for the 2024 elections and all future elections.

BE IT ALSO RESOLVED, the Aitkin County Board of Commissioners grants the County Auditor the right to add or remove Election Judges when appropriate throughout the 2024 Election season.
